HB 589 amends the current Community School Act language to include clear definitions of the community school framework;

- aligns implementation strategies with the current national research on highly effective community schools;**
- includes Pre-K in the definition of school-age when there is a free & optional program on the community school campus;**
- establishes a community school fund and the appropriates 5.1 million dollars to support community school development in New Mexico, and;**
- formally establishes a representative state-wide coalition for community schools.**
